Recognising the critical linkages between climate and nature, and the need for councils, capital cities and regions across Australia to urgently, and more effectively, connect their climate and nature actions, ICLEI Oceania has curated a unique, integrated suite of Climate and Nature (CaN) action offerings to support Australian councils – large or small, metropolitan, regional or remote – on their sustainability journeys.

The Climate and Nature (CaN) action suite includes practical tools, expert technical support and peer learning platforms to support Australian councils in accelerating local and state-level action, contributing not only to their current and future communities, but also to local and global targets, as direct, urgent and concrete responses to the climate and biodiversity emergencies.

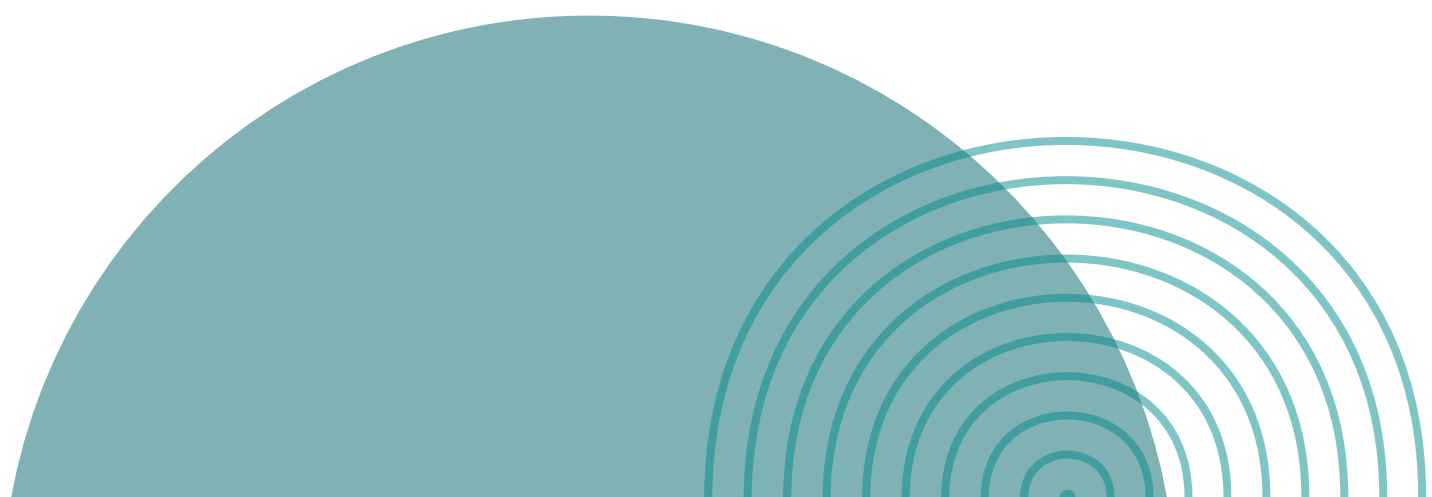
Australian councils CaN choose to participate in one or multiple initiatives/activities, creating their own path of climate and nature-related support, according to their needs and budget, regardless of how advanced their progress is in these areas of action.

Councils leading in this space have the opportunity to inspire, support and collaborate with other councils who are well on their way or just beginning their CaN journeys. They can also step up their advocacy on the global stage at the United Nations COPs via ICLEI as Local Governments and Municipal Authorities (LGMA) focal point for the United Nations Framework Convention on Climate Change (UNFCCC) and leading partner of the Global Partnership on Local and Subnational Action for Biodiversity for the Convention on Biological Diversity (CBD). Intermediate or less advanced councils will benefit from networking, collaboration, learning, support and inspiration from, and with, their peers.

CitiesWithNature Action Platform



FREE global [Action Platform](#) for councils to connect, learn and share targets, actions and case studies on what they are doing locally to help achieve global nature goals and targets. The platform is recognised by the Secretariat of the Convention on Biological Diversity as the official vehicle through which local and state governments report on their biodiversity commitments and ambitions towards the global [Biodiversity Plan](#) adopted in 2022 in Montreal at [CBD COP15](#). Through the platform, councils and regions benefit from leading expertise of close to 400 councils and regions already part of the initiative, of ICLEI's renowned [Cities Biodiversity Center](#) and our 15+ global partners including [UNEP](#), [IUCN](#) and many more.

Berlin Urban Nature Pact



NEW FREE initiative seeking to halt and reverse biodiversity loss and put nature on a path to recovery in councils worldwide by 2030. [The Pact](#) sets SMART targets across key areas like species and habitats, water management and blue infrastructure, soil health, and food and agriculture, and also offers concrete implementation guidance and principles to aid councils in their activities. Pact signatories will use the [CitiesWithNature Action Platform](#) to track the progress of their pact commitments.

Coastal Community of Practice*



A first-of its kind Australian cohort of coastal councils connecting mainly as an online Community of Practice. It provides curated space to share experiences, robust scientific tools, resources and best practices around coastal resilience and adaptation to climate change. This includes the use of nature-based solutions and ecosystem-based adaptation to navigate the different types of climate change impacts such as sea level rise, coastal erosion and storm surges. The work of this Community of Practice will contribute to ICLEI's global coastal and oceans advocacy work through the UN Oceans Conferences and related global platforms, served by ICLEI's leading global coastal coordinators and experts.

Town Hall COPs



A community engagement mechanism that empowers residents to actively contribute to local, national and global climate emergency commitments and actions. Together with elected leaders and Council officers, residents can discuss how to elevate local or subnational climate ambition and action, including council climate emergency declarations and climate neutrality commitments. Outcomes are reported to the Australian government to be integrated, as appropriate, in the next Nationally Determined Contributions for COP30 in November 2025 and via the Local Governments and Municipal Authorities Constituency engagement with the UNFCCC and at the Daring Cities annual forum.

ICLEI engages at the local to global levels, shaping policy and sparking action to transform urban environments worldwide. We build connections across levels of government, sectors and stakeholder groups, sparking city-to-city, city-to-region, local-to-global and local-to-national connections. By linking subnational, national and global actors, policies, commitments and initiatives, ICLEI strengthens action at all levels, in support of sustainable urban development.

At the subnational level, ICLEI drives change along five interconnected pathways that cut across sectors and jurisdictional boundaries. This design enables local and regional governments to develop solutions in a holistic and integrated way, creating change across entire urban systems.

These pathways, outlined below, are part of the ICLEI São Paulo Strategic Vision 2024 – 2030, which guides the work of the ICLEI network.



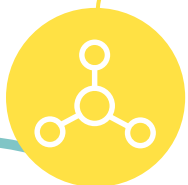
Zero emission development pathway

The zero emission development pathway curbs climate change, creates new economic opportunities and improves the health of people and natural systems.



Nature-based development pathway

Nature-based development protects and enhances the biodiversity and ecosystems in and around our cities, which underpin key aspects of our local economies and upon which we depend for the well-being and resilience of our communities.



Equitable development pathway

Equitable development builds just, livable, happy and inclusive urban communities, addresses the systemic causes of poverty and in- equality, and safeguards the natural support systems for human life.



Resilient development pathway

The resilient development pathway anticipates, prevents, absorbs and recovers from shocks and stresses, in particular those brought about by rapid environmental technological, social and demographic change, and improves essential basic response structures and functions.



Circular development pathway

Circular development, together with new models of production and consumption, builds sustainable societies that use recyclable, sharable and regenerative resources to end the linear model of “produce, consume, discard,” while continuing to meet the material and development needs of a growing global population.
